ADULT EDUCATION SUPPORT FUND GRANTS TO VOLUNTARY ORGANISATION 2002/03

REPORT BY THE DIRECTOR OF EDUCATION

**1 RECOMMENDATIONS**

The Committee is asked to approve grant aid to the Carnoustie Further Education Association of £1,290 (see Appendix).

**2 INTRODUCTION**

Adult Education Associations are managed locally by members of the community on a voluntary basis, with the following additional support being provided by the Council:

- 2.1) Grand Aid from the Adult Education Support Fund
- 2.2) Ongoing professional and administrative support from the Community Education Service
- 2.3) Access to the Council's payroll facilities for payment of class tutors' fees

The Associations provide evening classes, which are largely of a hobbyist and leisure nature.

Classes are wide ranging and are influenced by local demand. The 2001/2002 programmes included:

- Badminton, golf and yoga;
- Spanish, French, German and Gaelic;
- Computing; word-processing;
- Parenting skills;
- Aromatherapy and reflexology

Although the programmes are intended mainly for adults, there are examples of children's participation within foreign language classes. These numbers are not included for the purposes of grant aid from the Adult Education Support Fund.

Senior citizens, students, unemployed and those in receipt of income support are deemed to be eligible for a concessionary rate set by each local Adult Education Association.

**3 GRANT AID**

In the Education Committee Report No 396/96 on the Review of Letting Charges and Procedures, Angus Council approved free use of facilities to the Associations for classes of an educational nature; and concessionary rates for leisure and recreational classes with regular bookings of 35 meetings per year.

Grant aid is allocated across the following cost categories:

- A Organising Secretary's honorarium;
- B Administration and publicity;

C New development work (e.g. outreach in rural areas)

#### **4 FINANCIAL IMPLICATIONS**

From the sum allocated to the Revenue Budget for the purposes of the Adult Education Fund it is recommended that £1,290.00 in total be granted to Adult Education Associations. Appendix 1 provides details of the proposed allocation.

#### **5 CONSULTATION**

The Chief Executive, the Director of Finance and the Director of Law & Administration have been consulted in the preparation of this report.
