SUBJECT: TAYSIDE NATIVE WOODLANDS

#### REPORT BY DIRECTOR OF PLANNING AND TRANSPORT

Abstract: Angus Council is a funding member of Tayside Native Woodlands. This report recommends that the Council continues to fund projects undertaken by the company.

#### 1 RECOMMENDATION

It is recommended to the Committee that Angus Council contribute £5,500 in both the 2001/02 and 2002/03 financial years to Tayside Native Woodlands for the delivery of the first two years of the six projects detailed in Appendix A.

#### 2 INTRODUCTION

2.1 Tayside Native Woodlands (TNW) was incorporated as a company on 26 July 1996 and is now a registered charity. The aim of the company is "to ensure the multipurpose management, including expansion, of Tayside's native woodlands as an integral part of forestry and rural land use for public benefit". Angus Council is a funding member of the company and the Council's Countryside Officer is Angus Council's nominated Director on the Board of the company (report No. 219/96 refers). The other funding members are Scottish Enterprise Tayside, Scottish Natural Heritage, the Forestry Commission and Perth & Kinross Council.

#### 3 TAYSIDE NATIVE WOODLANDS

- 3.1 TNW currently employs three staff; a Project Director, a Project Officer; and an administrator. An independent Chairman has also been co-opted onto the Board.
- 3.2 Tayside Native Woodlands' achievements April 2000 December 2001:-
  - approximately 250 ha of native woodland brought into formal management within Angus;
  - 125 ha of new native woodland within Angus;
  - a total of 12 seminars were held of which 6 were within Angus, although all seminars were attended by individuals from throughout Tayside. Topics included the pruning and thinning of woodland to increase timber value and the collection of tree seed;
  - around 430 copies of TNW 'woodnote' advice and research publications distributed plus many downloaded from TNW website;

 TNW is working with other bodies to prepare a Heritage Lottery fund bid in order to deliver the Woodland Habitat Action Plan targets set out in the Tayside Biodiversity Action Plan;

- assisted 87 businesses through provision of information and linkages;
- in relation to the Community Woodlands Project, TNW is already working with communities in Tarfside, around Balkello Hill and Strathmartine Hospital and the nearby Baldovan Wood;
- 3.3 Funding is now sought towards the following six individual projects to be delivered by TNW:-
  - 1. Community Woodlands Project.
  - 2. Woodland Biodiversity Project.
  - 3. Tayside Veteran Tree Project.
  - 4. Tayside Native Woodlands Project.
  - 5. Best Practice Transfer.
  - 6. Helpline Service.

Details of each project are included in Appendix A.

#### 4 FINANCIAL IMPLICATIONS

4.1 Angus Council has contributed £5,000 towards the core funding of TNW each year between 1997/98 and 2000/2001. In order to assist the financial management of individual projects and increase transparency for funders, funding has now been sought on an individual project basis. The total Angus Council funding sought for the six projects in the first two years is £5,500 each year. A breakdown of the costs and contributions sought for each project is also contained within Appendix A. Whilst the funding sought represents an increase of £500 in relation to previous years, this can be contained within the Planning and Transport Department's Revenue budget (Rural Affairs) in both the 2001/2002 and 2002/2003 financial years.

# TAYSIDE NATIVE WOODLAND PROJECT FOR WHICH ANGUS COUNCIL FUNDING IS REQUESTED

#### 1. COMMUNITY WOODLANDS PROJECT

**<u>Aim:</u>** To expand community involvement in woodlands in Tayside.

TNW and others will provide information, support and advice to communities who wish to be more involved in the management of their local woodlands in Tayside.

#### **Objectives:**

- 1. To raise awareness of the opportunities available to communities for involvement in the management of their local woodland.
- 2. Provide a one-stop-shop service to community groups requiring advice, support and information on all aspects of establishing a community woodland group
- 3. Provide follow up training to assist communities with their skill development
- <u>4.</u> Provide on-going expertise, advice and support to communities as they develop their project.

<u>The Need:</u> There is great concern from the general public regarding the environment as a whole and in particular the management of the countryside. Most people live and work within towns and cities, but they spend a considerable amount of their leisure time in the countryside. Within Tayside 80% of all native woodlands are within 3 miles of the nearest sizeable population (TNWI 1995). Many people feel they have little or no influence on the management of the countryside around them and therefore on their future heritage.

Since a substantial proportion of forestry activity is subsidised by the taxpayer, to the tune £1.4 million in Tayside in 2000/01 there is increasing demand from the public to have a greater say in how and where this money is spent. This project will allow local communities to be actively involved in the management of their local woodland. Support will be given to local communities through a number of mechanisms including relevant training provision, free access to independent forestry and /or conservation advice. It will also provide a mechanism where rural and urban communities can work together towards a common goal, facilitating greater understanding between these two communities and promoting mutual cooperation.

If this project is not funded then people living in Tayside may not be able to realise the full potential of direct influence in the management of the woodlands around them and the divide between urban and rural communities will continue to grow. The opportunities for establishing community networks and local skill development will be missed.

Supporting this project will allow local people to potentially participate in the decision making process about countryside management. The benefits of an active, thriving, participatory community will reach well beyond the woodland gate.

# **Outputs:**

- 5000 information leaflets distributed to local groups
- 40 community groups contacted directly and provided with information on community woodlands
- 100 community woodland packs developed providing all the information and advice require for each group
- 20 Community Woodland information seminars/ workshops delivered to over 200 local group leaders
- Exchange of information with already established community woodland groups, enabling skill transfer and transfer of best practice.
- 5 community woodland groups established, woodland identified and negotiations with the owner begun
- 7 Quarterly newsletters to allow each group to be kept informed of community woodland developments within and beyond Tayside
- Significant increase in transferable skills attained by the community
- United community working towards a common purpose
- Increased recreational resource for the community
- Increased quality of life
- Improved job prospects within the community
- Greater control of their rural economy
- Plus many intangible benefits, which are difficult to measure such as increased sense of well-being. These things are also very important to rural communities

# 2. WOODLAND BIODIVERSITY PROJECT

<u>Aim:</u> To secure match funding for £600,000 WGS from FC from Heritage Lottery Fund to deliver woodland habitat action plan targets as outlined in the Tayside LBAP

## **Objectives:**

- 1. Secure funding for expansion of MLURI Native Woodland Potential Model for all of lowland Tayside and contract MLURI to undertake work
- 2. Produce composite data set of all woodland data to determine 'Woodland Biodiversity Hot-Spots'
- 3. Organise Forum for discussion with relevant interested parties to discuss proposals (include land owners, forestry agents and consultants, public agencies and Local Authorities)
- 4. Secure funding for development of a Stage I bid for £600,000 to HLF

#### **Outputs:**

- Enable stage I of the £1,2 million bid to be progressed
- Prioritised areas within Tayside for delivery of woodland habitat action plans providing the best biodiversity

## 3. TAYSIDE VETERAN TREE PROJECT

<u>Aim:</u> To enable the general public in Tayside to learn more about the environmental, cultural and historical importance of their veteran trees.

## **Objectives:**

- 1. Involvement of the public to identify trees, which are important in their local environment.
- 2. Provide training workshops for the general public to complete phase 1 level surveys for ancient & veteran trees.
- 3. Provide training to Tree wardens and interested members of the public (at a subsidised rate) to be involved in follow up phase I surveys with more detailed surveys
- 4. Collation of information from the Woodland inventory maps of Scotland (Caledonian Partnership maps), where individual trees are identified. Tree wardens and trained surveyors to go and survey trees (experts or trained volunteers probably pay an expenses rate for car etc)
- 5. History follow up examine old maps, historical evidence
- 6. Promote trees as part of Big Tree Country

# **Outputs:**

- Production of 1000 leaflets to publicise the project and the benefits to local people
- 500 trees surveyed and the information added to the web site
- 10 'Tree detective' workshops given free to members of the public
- 300 people trained to undertake level I surveys
- Tree wardens and nature groups trained to undertake level II surveys
- Maps produced of distribution and condition of veteran trees in Tayside which will be used to develop the Wood Pasture & Parkland Habitat Action Plan as part of the LBAP process
- Report produced for use by other LBAPs and other agencies including the Woodland Trust to undertake similar work in the UK
