BEST VALUE SERVICE REVIEW PROGRAMME

REPORT BY CONTRACT SERVICES MANAGER

ABSTRACT

This report details Contract Services' Programme for Service Review required under the Scottish Office Best Value Guidelines and covering a five year period.

1. RECOMMENDATION

- a) It is recommended that the Committee should note the contents of this report;
- b) Approve the Service Review Programme annexed;
- c) Note that any future variations in the programme will be reported in due course.

2. BACKGROUND

Members will be aware that under the Best Value Regime local authorities are required to review all of their operations over a five year period. The Council-wide master programme was submitted to, and approved by, the Policy and Resources Committee on 12 May 1998 under report R504/98. This report required that departmental review plans be submitted to appropriate Committees.

3. DETAILS

In order to have a balanced review over the stipulated period, the individual services that comprise Angus Contracts have been sub-divided into activities suitable for review. Where appropriate, consultation has taken place with the Client departments in order that joint reviews can be undertaken. A detailed programme is shown in Appendix 1 and the initial tranche will be undertaken whenever the Lead Officers have received appropriate training. The 1998/99 reviews are:-

- Street Cleaning. A joint review with the Client who will provide the Lead Officer and covers all aspects of Street Cleaning.
- Leisure Management Systems will cover the departmental formalised management systems and will play a significant part in preparation for Quality Accreditation.
- DLO Operations. A joint review with Housing Department in which Contract Services will supply the Lead Officer and will cover all aspects of the painting and plumbing work carried out by the DLO.

4. FINANCIAL IMPLICATIONS

There are no financial implications directly attributable to this report as all staff costs will be contained within departmental budgets.

5. CONSULTATION

The Chief Executive, Director of Finance and Director of Law and Administration have been consulted in the preparation of this report.
