STANDARDS IN SCOTLAND'S SCHOOLS ETC ACT 2000

REPORT BY THE DIRECTOR OF EDUCATION

ABSTRACT

This report draws the Committee's attention to a new and potentially important piece of legislation.

1 RECOMMENDATIONS

It is recommended that the Education Committee:

- a notes the commencement dates of the various Sections of the Standards in Scotland's Schools etc Act 2000 (Annex A)
- b notes that the full text of the Act is available for perusal on the internet at www.scotland-legislation.hmso.gov.uk
- c delegates to the Directors of Education and Law & Administration the task of ensuring that the Council complies with the terms of the Act, and of keeping the Education Committee informed on progress with this task as appropriate.

2 BACKGROUND

- 2.1 At the meeting of the Education Committee on 19 October 1999, consideration was given to a draft "Improvement in Scottish Education" Bill, and to a consultation document on the General Teaching Council for Scotland (Articles 3 (a) and 3 (b) of the note of the meeting refer).
- 2.2 The parliamentary process considering both these matters has culminated in one of the first major pieces of legislation to emerge from the Scottish Parliament – The Standards in Scotland's Schools etc Act 2000.
- 2.3 This Act received Royal Assent on 14 July 2000.
- 2.4 On 15 September 2000, the Scottish Executive issued SEED Circular No 2/2000. Annex A to that Circular is appended to this report. It sets out the commencement date for each of the Act's 61 Sections and three Schedules.

3 DETAILED IMPLICATIONS

- 3.1 Several Sections of the Act, although important to the functioning of the Scottish education service as a whole, will impinge only indirectly on the powers and duties of the Council (eg Sections 45 to 52 on the GTC, Sections 17 to 23 on self governing schools).

- 3.2 Several Sections within the Act largely reflect current practice, although that practice is now to be governed by the law (eg School Development Plans – Section 6; Education Authorities Annual Statement of Improvement Objectives – Section 5). Some work is likely to be required in order to ensure full compliance with the detailed terms of the Act.
- 3.3 There are some Sections which will require careful consideration to ensure that the Council's procedures and policies are fully compliant with the law as it now stands.
- 3.4 Much of the work now required can be taken forward by officers of the Council (including teaching staff) and should be essentially operational in nature. It is proposed that responsibility for undertaking this work should be delegated to the Director of Education and the Director of Law & Administration, on the understanding that the Education Committee is appropriately apprised of any issues which require its attention.

4 CONSULTATION

- 4.1 In accordance with the Standing Orders of the Council, this report has been the subject of consultation with the Chief Executive, the Director of Finance and the Director of Law & Administration.
