## **ACCESSIBILITY IN ANGUS SCHOOLS - UPDATE**

# JOINT REPORT BY THE DIRECTOR OF EDUCATION AND THE DIRECTOR OF PROPERTY SERVICES

#### **ABSTRACT**

This report outlines progress to date and outlines further proposals to utilise resources provided by the Scottish Executive to improve the accessibility of schools for pupils, staff and wider community.

## 1. RECOMMENDATION

It is recommended that the Education Committee note the content of this report.

It is recommended that the Resources and Central Services committee should:

- (i) note the content of this report
- (ii) instruct the Director of Property Services to procure the necessary works.

## 2. INTRODUCTION

At its meeting of 19 August 2004 the Education Committee approved report 877/04 in respect of Accessibility in Angus Schools. The report outlined the implications of The Educational (Disability Strategies and Pupils' Educational Records) Act 2002 which requires responsible bodies to prepare and implement accessibility strategies to improve, over time, access to education for pupils (and prospective pupils) with disabilities. The aim is through long-term strategic planning to improve access for all pupils with disabilities. In particular the Committee approved a range of improvements to school buildings.

Based on most recent information it is anticipated the total expenditure in the current financial year will be £220,000. Due to slippage on particular projects, e.g. Grange Primary School and Lochside Primary School, it is now anticipated that expenditure in 2004/05 will be lower than anticipated while expenditure in 2005/06 will be correspondingly higher. This is illustrated in the following table:
