## SUBJECT: DUNDEE, PERTH, ANGUS AND NORTH FIFE STRATEGIC DEVELOPMENT PLANNING AUTHORITY - UPDATE

#### REPORT BY DIRECTOR OF INFRASTRUCTURE SERVICES

Abstract: This report sets out for ratification the remits of the Dundee, Perth, Angus and North Fife Strategic Development Plan Authority Joint Committee which was held on 25 November 2008.

#### 2 INTRODUCTION

2.1 At the meeting of the Dundee, Perth, Angus and North Fife Strategic Development Planning Authority Joint Committee held on 25 November 2008 the following reports were agreed:

06/2008	Proposed staffing and draft budget for the Strategic Development

07/2008	Research requirements for the Strategic Development Plan.

- 2.2 Under the Joint Committee's constitution all decisions must be referred back to the relevant Committees of the Constituent Authorities for ratification. The remits of the Joint Committee are set out in Appendix 1 of this report.
- 2.3 It should also be noted that the Convener of the Joint Committee for 2009, is held by Councillor David May, Convener of Infrastructure Services Committee, Angus Council with Councillor Kevin Keenan, Dundee City Council as Vice Convener. - 2.4 This report sets out in Appendix 1 the decisions of the Joint Committee for approval by the Infrastructure Services Committee.

### 3 FINANCIAL IMPLICATIONS

3.1 The financial implications of the shared costs for the establishment and maintenance of the Strategic Development Plan Authority for the Dundee, Perth, Angus and North Fife area have been dealt with through the 2009/10 budgetary process and a figure

of £60,000 has been included in the provisional Planning & Transport Division Revenue budget for 2009/10.

At this stage initial work is ongoing to establish the administrative, staffing and financial protocols that will support future work in preparing the new TAYplan.

7.1 The Chief Executive, Director of Corporate Services, Head of Finance and Head of Law & Administration have been consulted in the preparation of this report.

#### 8 CONCLUSION

8.1 Progress continues to be made in establishing the Dundee, Perth, Angus and North Fife Strategic Development Plan Authority and ratification of the remits set out in this report will assist in that process.

## Report 05/2008 Update on the setting up of the Strategic Development Plan Authority

Report No 05/2008 was submitted by the Interim Strategic Development Plan Manager updating the Joint Committee on progress being made with regard to the setting up of the Strategic Development planning Authority.

The Joint Committee agreed to:-

- a) note that the proposed boundary for the SDPA has been approved by Scottish Ministers with no changes;
- b) note that the Scottish Government had agreed to release a grant of £120,000 to assist with the start-up costs of the SDPA and agreed that Dundee City Council provide written confirmation on the areas of expenditure as requested;
- c) note the progress being made towards the co-location of the dedicated team with Scottish Enterprise;
- d) note the progress made with regards to the recruitment of the SDPA team members;
- e) note the Logo to be used for TAYplan documentation and stationary;
- f) note that that Dundee City Council would be the employing authority for all the staff of the SDPA;
- g) agree the provision of member council support roles as set out in paragraphs 8.2 to 8.4 and refer this to each constituent Council for ratification; and
- h) note the Project Plan would be updated to take account of the revised publication date for the Development Planning Regulations (January 2009 rather than October 2008).

A map of the approved boundary was circulated, and it was noted that Scottish Ministers had intimated that notwithstanding the proposed changes to the Cairngorms National Park Boundary, Scottish Ministers did not intend to make any changes to the SDPA boundary at this time.

With regard to the location of the dedicated team within Scottish enterprise accommodation, it was reported that it was hoped to finalise details in the very near future.

# Report 06/2008 Proposed staffing and draft budget for the Strategic Development Planning Authority

Report No 06/2008 by the Interim Strategic Development Plan Manager was submitted to the Joint Committee seeking approval of the staffing arrangements and draft budget for the SDPA.

The Joint Committee agreed:-

- a) that each constituent authority commit to providing at least one full time equivalent staff resource to the SDPA.
- b) the draft budget for the Strategic Development Planning Authority.

c) to refer the decisions on the additional staffing and draft budget to each constituent authority for ratification.

## Report 07/2008 Research requirements for the Strategic Development Plan

Report No 07/2008 by the Interim Strategic Development Plan Manager was submitted to the Joint Committee advising the Committee of the areas where research studies will be required to inform the preparation of the Strategic Development Plan and to note the use of consultants to carry out these studies.

The Joint Committee agreed:-

a) note the requirement to appoint consultants to carry out studies considered necessary to inform the preparation of the Strategic Development Plan.
