### **ABSTRACT**

This report informs the Committee of Road Construction Consents which were granted in 2008/09.

### 4 FINANCIAL IMPLICATIONS

The revenue implications in respect of the routine and winter maintenance for the roads and street lighting when these are added to the List of Public Roads, based on current rates, will be £11,350 per annum. This additional cost will be addressed through the normal budget setting process at the time of adoption of these roads.
