NEIGHBOURHOOD SERVICES COMMITTEE - 19 NOVEMBER 2009 PARKS AND OPEN SPACES STRATEGY AND AUDIT PROGRAMME REPORT BY DIRECTOR OF NEIGHBOURHOOD SERVICES

ABSTRACT: To advise Committee on the progress and programme to complete the draft Parks and Open Space Strategy and Open Spaces Audit.

1. RECOMMENDATION(S)

- 1.1 It is recommended that the Committee agree:-
 - (i) Note the contents of the report;
 - (ii) Agree the programme to prepare a draft Parks and Open Space Strategy document for review by Committee before putting out to final public consultation.
 - (iii) To seek authorisation to carry out all the required steps under SEA for the Parks and Open Spaces Strategy up to the point of its adoption by the Council to ensure compliance with the requirements of the 2005 Act

2. BACKGROUND

- 2.1 The Scottish Government published **Scottish Planning Policy 11**, **Open Spaces and Physical Activity.** It requires all Scottish Local Authorities to undertake an audit of the Open Spaces in their area and prepare an Open Space Strategy to help guide planning, policy and open space management and maintenance and reference is made to report 499/05 of The Environmental and Leisure Services Committee.
- 2.2 Adhering to these policy guidelines to develop an Open Space Strategy the following broad headings require to be developed:

(i) To develop a Green Space Audit (Full Local Authority wide)

(ii) To develop a draft Strategy (Objectives)

(iii) To develop a draft action plan (Delivery)

3. CURRENT POSITION

3.1 The Corporate Open Spaces audit is progressing with the audit of Open Spaces being completed by March 2010, in addition a review of children's play areas is being undertaken and should be completed in late Dec 2009 which will form part of the overall Open Space Strategy

It is proposed to complete the draft Strategy for review by committee in May 2010
