# 2. PROGRESS AGAINST ACTIONS IN SERVICE IMPROVEMENT PLAN

We will increase the range and volume of physical activity and physical education in all schools		31-May-2011	Very positive work continues to take place in these areas. #### 4. FORMAL CONSULTATIONS UNDERTAKEN

### **ARBROATH SCHOOLS PROJECT (PHASE 1)**

Education Committee report 400/11 provided feedback on the consultation exercise undertaken in relation to the proposals to provide a new primary school in the West of Arbroath and included the formal Consultation Report, prepared in accordance with the Schools (Consultation) (Scotland) Act 2010.

The formal consultation process commenced on Tuesday 16 February 2011 and concluded on Friday 1 April 2011.

During the consultation period, the Council received a number of written comments/representations **and** oral comments/representations at the public meeting held at Arbroath High School on Tuesday 8 March 2011. Written and oral comments included those comments from parties who are not relevant consultees. However, <u>all</u> comments received were summarised in sections 5 and 6 of the report.

Her Majesty's Inspectorate of Education (HMIE) submitted a report to the Council relating to the educational aspects of the Proposal.

The proposal to close Muirfield primary School and Timmergreens Primary School and replace them by a new build school on a site adjacent to Hospitalfield House was approved by Angus Council on 22 June 2011 and formally submitted to Scottish Government on 24 June 2011.

The Council's decision was called in by the Minister on 28 July 2011. His statutory response is awaited following consideration of related matters.

#### 5. EXTERNAL PERFORMANCE AUDIT/INSPECTIONS

Seven primary schools and their nursery classes were inspected by HMIe all receiving positive inspection reports. (Positive inspections are defined as inspections where the ratings against each of five key indicators are at level 3 ["satisfactory"] or above).

#### 6. REVENUE BUDGET MONITORING

The Education Department is currently projecting a net underspend of £247k between outturn net expenditure and the revenue budget. The main reasons for the variance are as follows:

- the Department is currently projecting minor £140k slippage in respect of teachers' and Early Years Practitioners' salary costs within the Primary and Nursery budgets respectively. At this time we are not anticipating any issues with regard to teacher absence cover. However, this matter needs to be closely monitored over the winter months. The impact of the changes to teachers' national terms and conditions is also being closely monitored
- while rates are currently in an overspend position, the projection assumes that this overspend will be offset by a corporate contribution (budget uplift). It should also be noted that property maintenance and energy costs have been projected in line with the budget
- the projected cost of residential school placements is currently indicating an underspend. It is proposed to make a budget carry forward request in relation to the underspend of £110k to help offset possible future year overspends. An application will be made in due course to the Head of Finance for subsequent approval by the Strategic Policy Committee. The current net projected underspend assumes that the budget carry forward request will be successful
- the Department is currently projecting an £110k overspend on school transport costs as a result of higher than anticipated fuel-related inflationary increases, applicable to all school conveyance contracts.
