**EXTENDED HOURS OVER 2012 FESTIVE PERIOD**

**FOR LATE HOURS CATERING PREMISES**

**REPORT BY THE DIRECTOR OF CORPORATE SERVICES**

**ABSTRACT**

The purpose of this report is to allow members to consider whether they wish to make extensions of hours available to late hours catering premises over the festive period.

**1. RECOMMENDATION**

The Committee is requested to consider and either:-

- (i) approve an extension of one additional hour at the end of trading on Christmas Eve (Monday), Christmas Day (Tuesday), Hogmanay (Monday) and New Year's Day (Tuesday) only for all late hours catering premises in Angus. This would permit late hours catering premises to operate on Christmas Eve, Hogmanay, Christmas Day and New Year's Day until 1 am; or
- (ii) refuse any additional hours.

**2. BACKGROUND**

- 2.1 Members will recall that traditionally, Angus Licensing Board has agreed to permit liquor licensed premises, excluding off sales, to apply for additional hours beyond guidelines over the festive period. Angus Licensing Board's Statement of Licensing Policy was approved by the Board at its meeting on 24 November 2010. This Statement provides that the Board will permit on sale premises one additional hour at the end of trading on Christmas Eve, Christmas Day, Hogmanay and New Years' Day. However, the Board will not permit this extension of hours if it would result in premises trading beyond 2am. If applicants wished to take advantage of this relaxation, then they were required to include provision for it in their Operating Plan, or apply for an extension of hours in terms of Sections 67 to 70 of the Licensing (Scotland) Act 2005. It has been the practice of this committee and the Licensing Board to agree the same extension of hours for both late hours catering establishments and liquor licensed premises.
- 2.2 Members are asked to consider whether they wish to offer the one additional hour to Late Hours Catering premises. In reaching a decision members are reminded that the general policy is that these premises ought to close prior to the closing time for liquor premises. However, if granted this additional hour will result in most liquor premises and late hours catering premises closing at the same time for these four nights.

**3. RISKS**

This report does not require any specific risk issues to be addressed.

**4. FINANCIAL IMPLICATIONS**

There are no financial implications arising from this report.
