ABSTRACT

The purpose of this Report is to advise members of applications for a Personal Licence under the Licensing (Scotland) Act 2005 which have been granted by the Clerk to the Licensing Board in accordance with the Scheme of Delegation appended to the Licensing Policy.

1. RECOMMENDATION

2. BACKGROUND
